Online Temporary Protective Status Packet for Haitian Nationals

Passport, birth certificate with photo identification, or national identity from your country with photo or fingerprint)
- Proof of entry date into the U.S.:
passport, I-94 (if available)
- Two passport style photos
- Copy of any previous employment card
- Proof of residence in the U.S.:
 - Employment records, pay stubs, Income tax return
 - Rent receipt, utility bills
 - School records showing names and dates of school attendance
 - Hospital or medical records showing names of physician and dates of treatment
 - Attestation by churches, unions or organizations showing date of membership
 - Passport entry stamps, birth certificates of children born in the United States
 - Social security card, auto license receipts, vehicle registration, deeds, mortgages

All documents must have English translation
